1 Account Setup

A transponder can be moved from vehicle to vehicle as long as the license plate for each vehicle is added to your account.

EQUITY ACCOUNTS

Qualifying Commuters receive a \$25 toll discount during account set-up. Must reside in L.A. County and have an annual income at or below \$37,060 (family of 3). Limit one per household.

2 Account Replenishment (Both Standard and Equity Accounts)

Your card will automatically be charged \$40 or the equivalent of one month's usage averaged over a three month period (whichever amount is greater) each time your account balance falls below \$20. For cash accounts, you must make additional payments of \$50 to your account whenever your pre-paid toll balance falls below \$25.

EXPLANATIONS:

1. Transponder Deposit is refundable when account is closed and the transponder is returned in good working condition.
2. Waived for Equity Account holders. Waived for Standard Account holders who make four one-way trips per month on the Metro ExpressLanes in any combination of transit, carpool, vanpool, or toll paying SOV.
3. If your card is declined during replenishment, your account automatically becomes a cash account and you will need to either supply a new card or pay your account balance with cash or check and provide a transponder deposit.
4. Waived if you choose to have your statement mailed quarterly or emailed monthly.
5. Charged when an account exceeds 10 photo processed transactions in a month.
