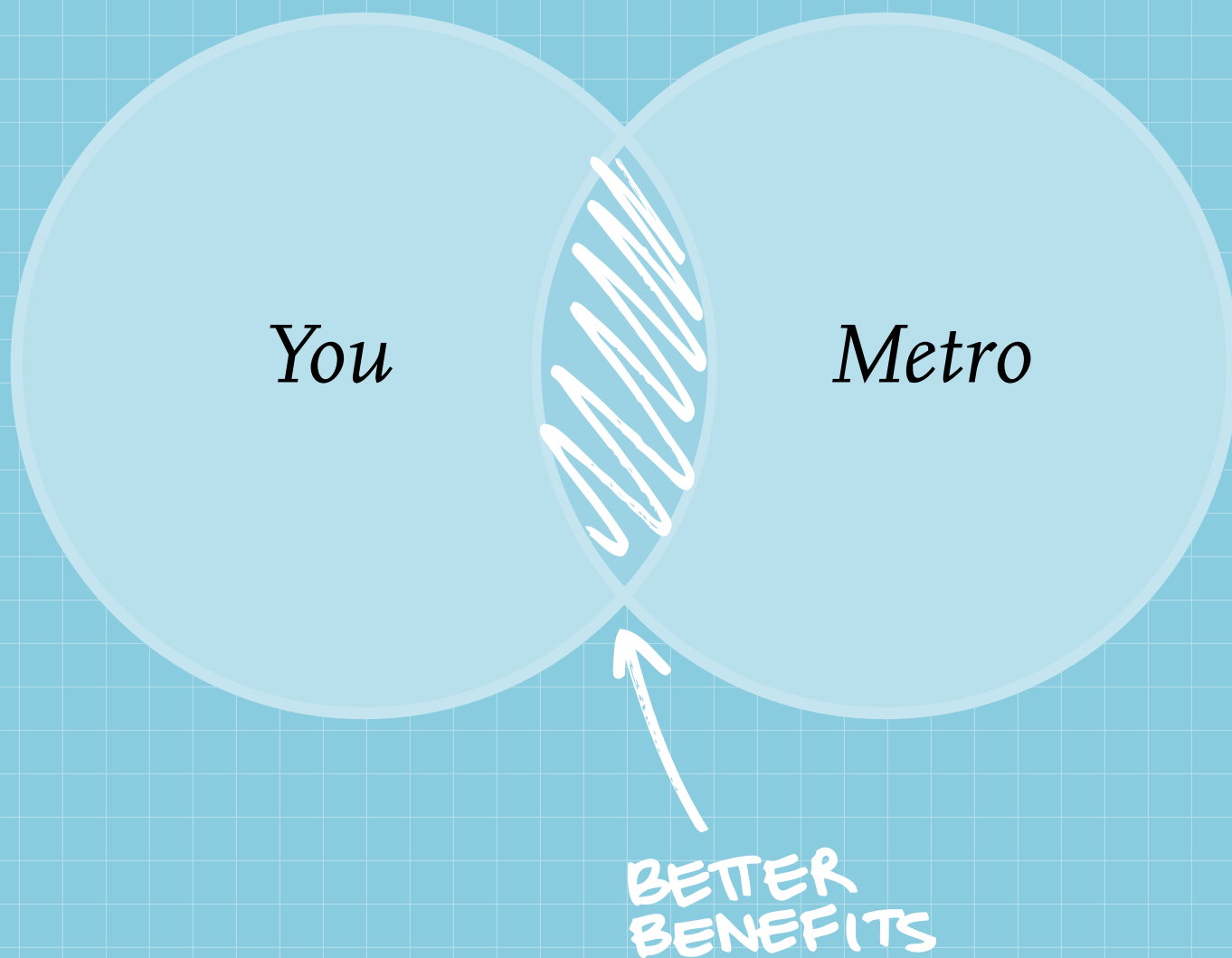
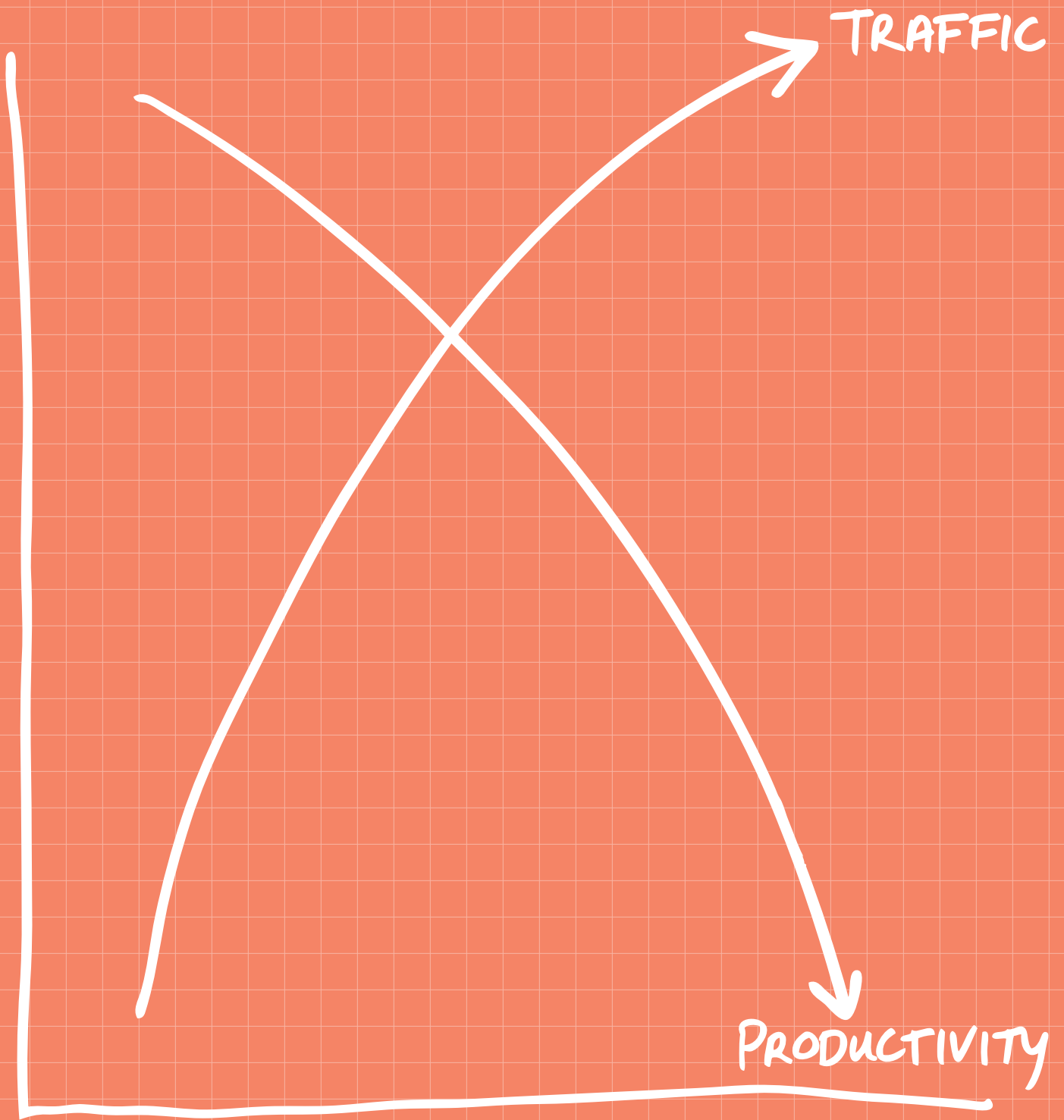

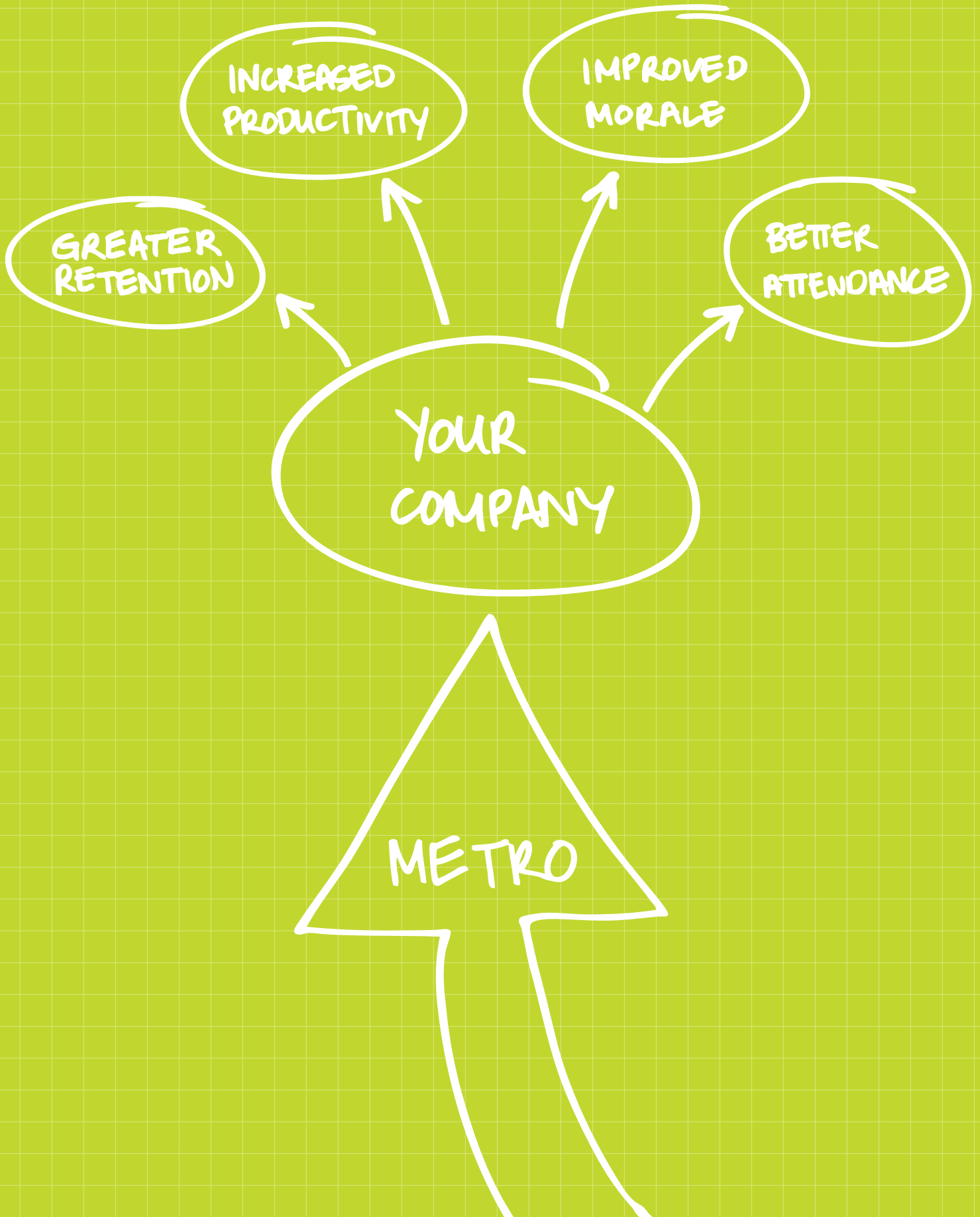
## Is your business stuck in traffic?

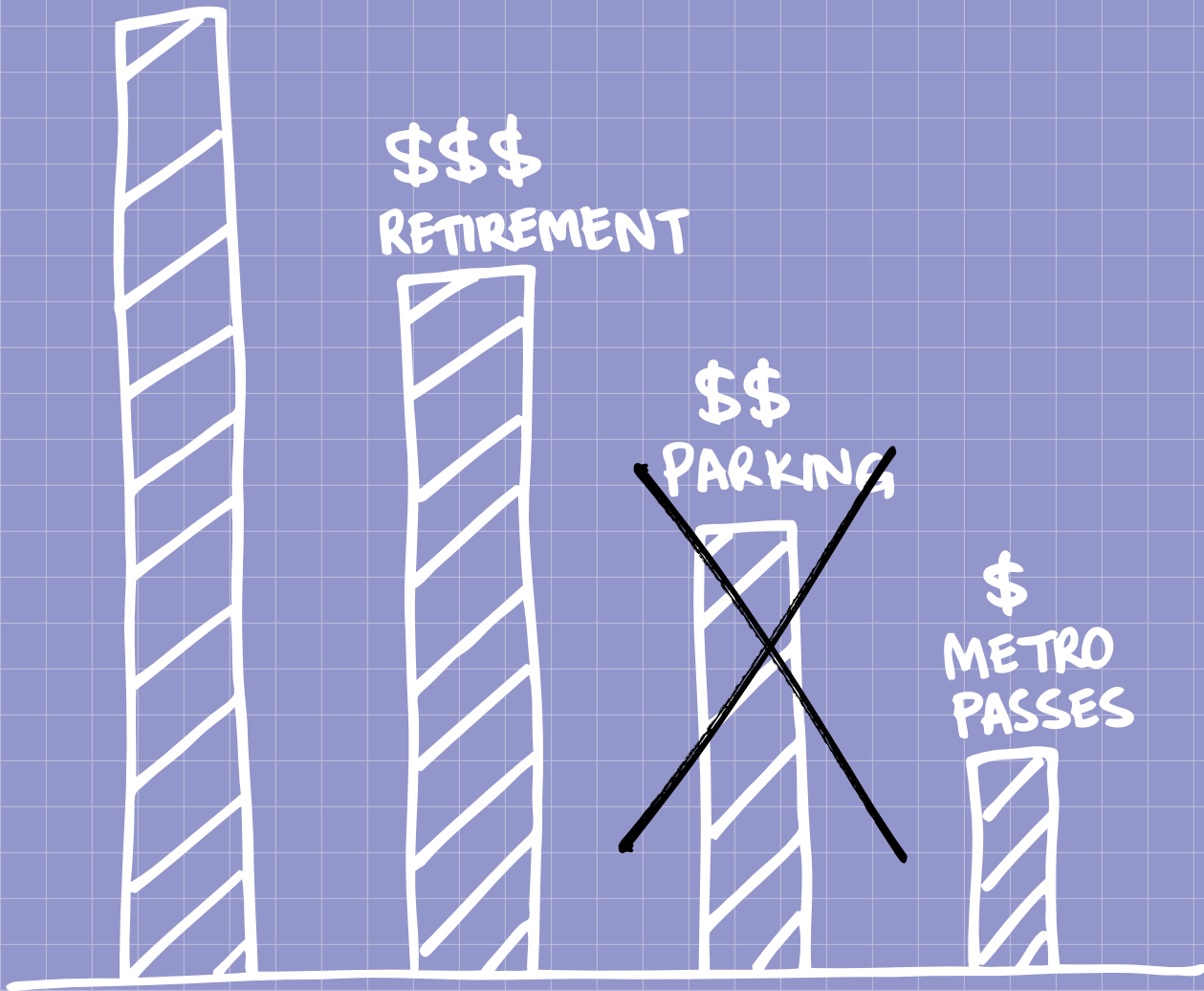

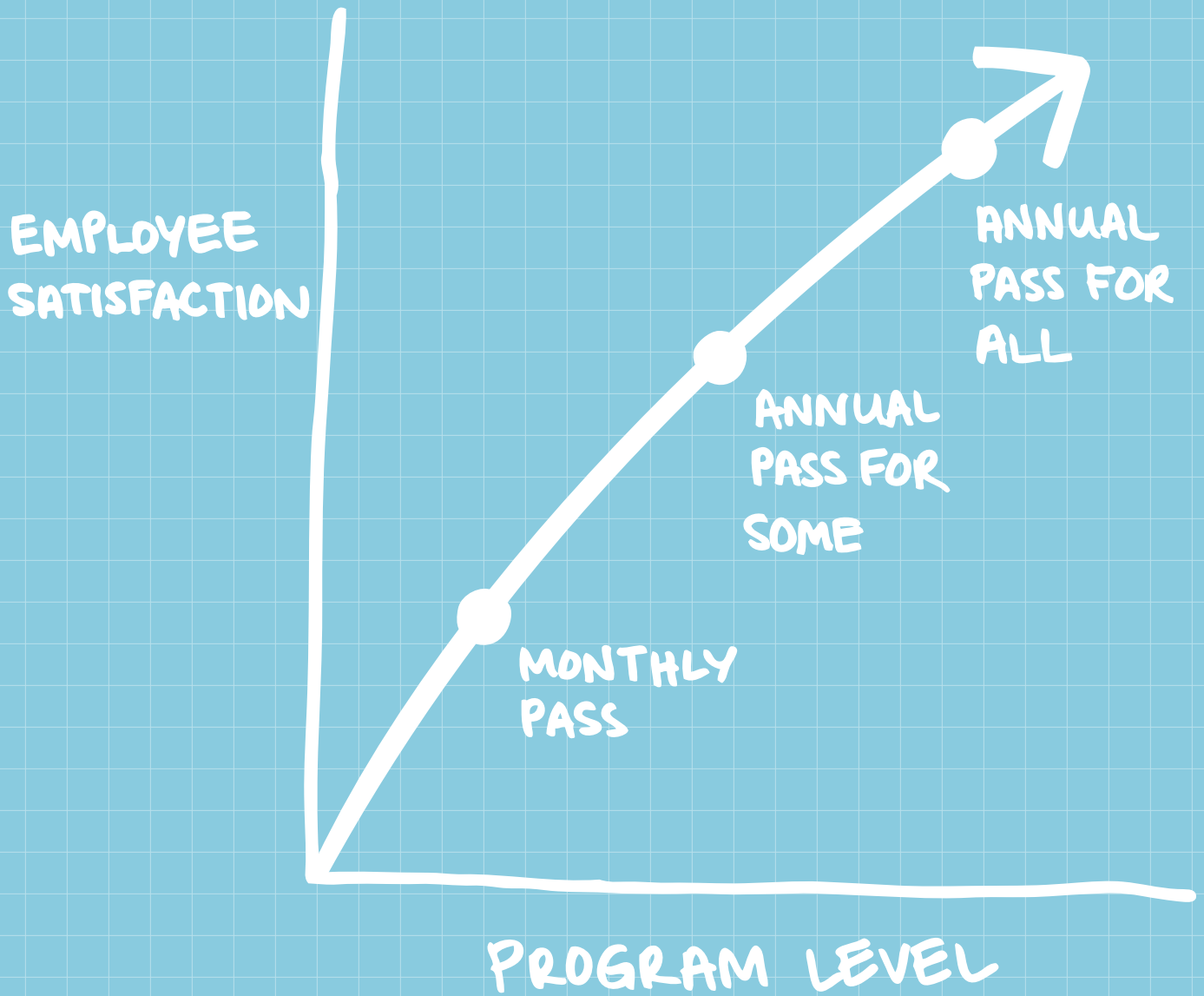

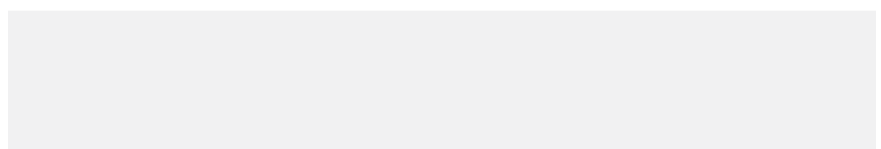
