At Metrolink, we are working to make all aspects of your commute both pleasant and convenient. With Metrolink's Pass By Mail you can have the convenience of having your Metrolink Monthly Pass or 10-Trip Ticket delivered to your home or office by simply filling out this form and mailing it in with your payment. We'll take care of the rest.

### GUIDELINES

**Monthly Pass:** Valid for unlimited travel between the selected origin and destination stations during the calendar month indicated on the pass. The pass must be signed and is non-transferable.

**10-Trip Ticket:** Valid for ten (10) one-way trips between the origin and destination stations indicated on ticket within 90 days of issue. Ticket may be used by more than one passenger. Ticket must be validated once per passenger prior to boarding.

**Senior/Disabled Fares:** 50% off adult peak fares at all times. Be prepared to show proof of age (65+) or disability to conductor upon request. Passengers without valid identification are subject to citation and fine.
