## I-10 ExpressLanes Extension Project

**Reminder: You have until Friday June 10, 2022 to provide official comment.**

Metro, in coordination with Caltrans, is initiating an Environmental Impact Report/Environmental Assessment (EIR/EA) for the proposed I-10 ExpressLanes Extension project. The EIR/EA is under development to evaluate the potential environmental impacts associated with the implementation of ExpressLanes or additional HOV lanes on the I-10 corridor between I-605 and the Los Angeles/San Bernardino County line.

### Public Scoping Comment Period Closing Soon

As part of the project's environmental process, a formal public scoping comment period was initiated with the posting of the [Notice of Preparation](#) and will run from Monday, April 25, 2022, through Friday, June 10, 2022.

We encourage you to submit comments on the proposed alternatives, purpose and need, as well as help identify and inform the issues that may need to be addressed in the environmental process.
