Shows the area within a half-mile of the street network

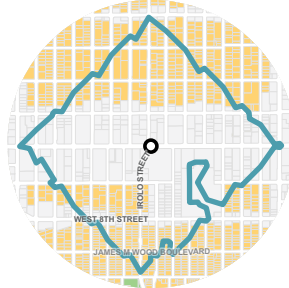

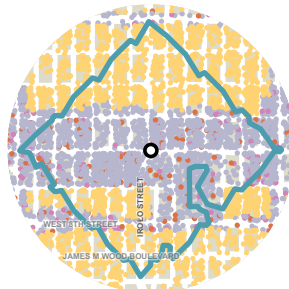

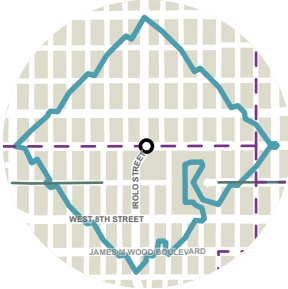

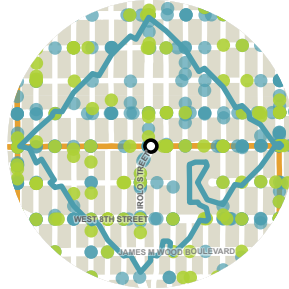

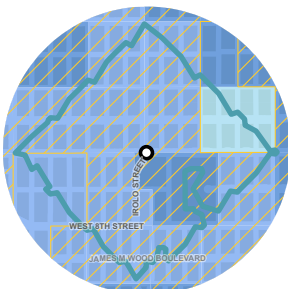

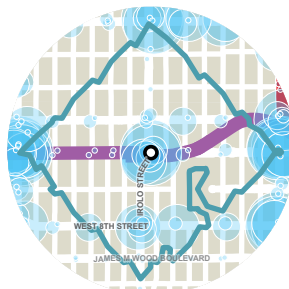
