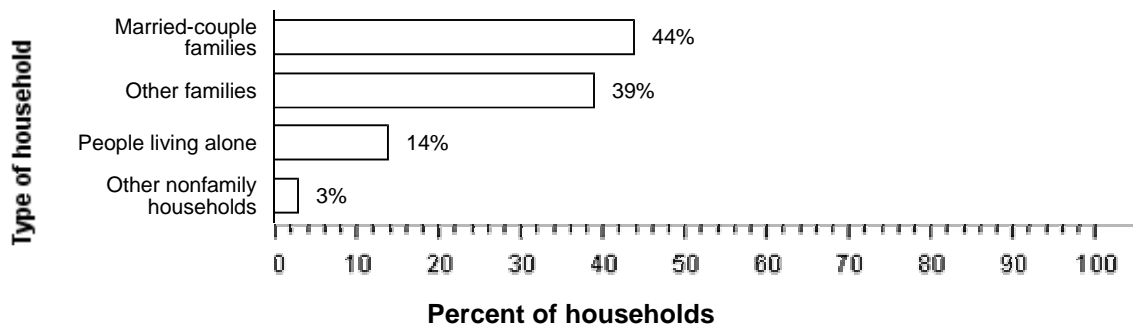
NOTE. HOUSEHOLDS AND FAMILIES: In 2007-2009 there were 22,000 households in Compton city. The average household size was 4.2 people.

Families made up 82 percent of the households in Compton city. This figure includes both married-couple families (44 percent) and other families (39 percent). Nonfamily households made up 18 percent of all households in Compton city. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

The Types of Households in Compton city, California in 2007-2009

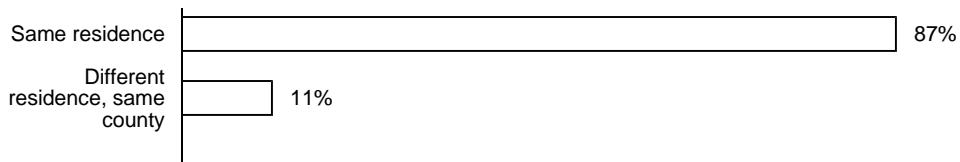


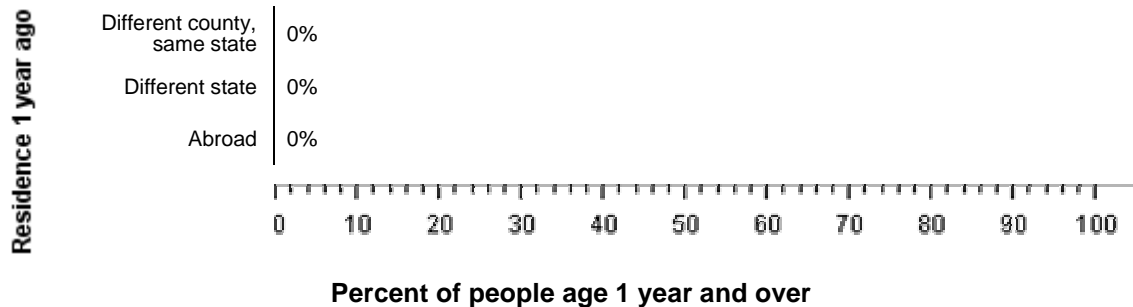

NATIVITY AND LANGUAGE: Data for this section cannot be displayed because the number of sample cases is too small. Displaying the data would risk disclosing information for individuals.

GEOGRAPHIC MOBILITY: In 2007-2009, 87 percent of the people at least one year old living in Compton city were living in the same residence one year earlier; 11 percent had moved during the past year from another residence in the same county, less than 0.5 percent from another county in the same state, less than 0.5 percent from another state, and less than 0.5 percent from abroad.

Geographic Mobility of Residents of Compton city, California in 2007-2009



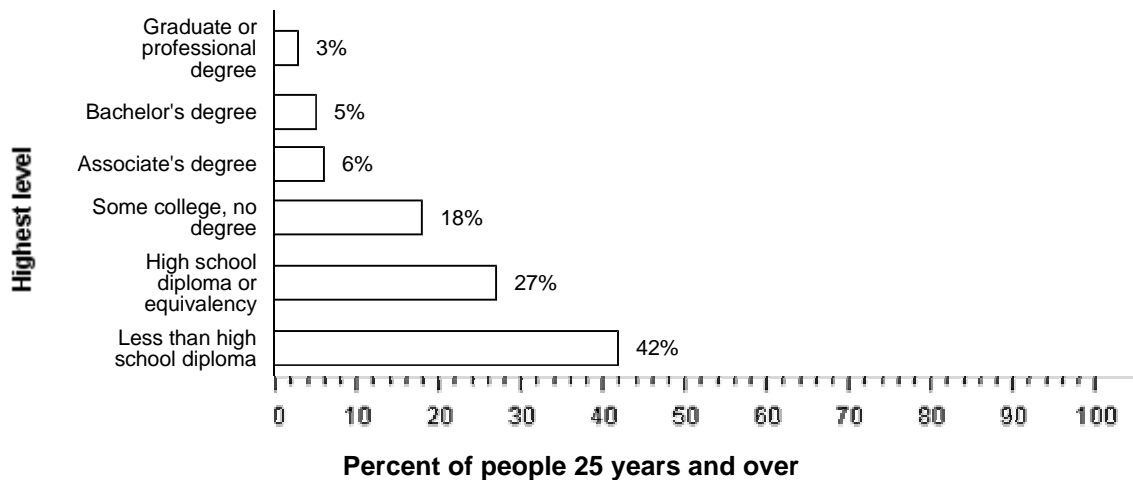

EDUCATION: In 2007-2009, 58 percent of people 25 years and over had at least graduated from high school and 8 percent had a bachelor's degree or higher. Forty-two percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Compton city was 32,000 in 2007-2009. Nursery school and kindergarten enrollment was 3,800 and elementary or high school enrollment was 23,000 children. College or graduate school enrollment was 5,600.

The Educational Attainment of People in Compton city, California in 2007-2009

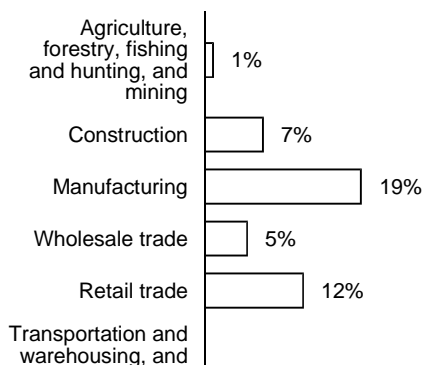


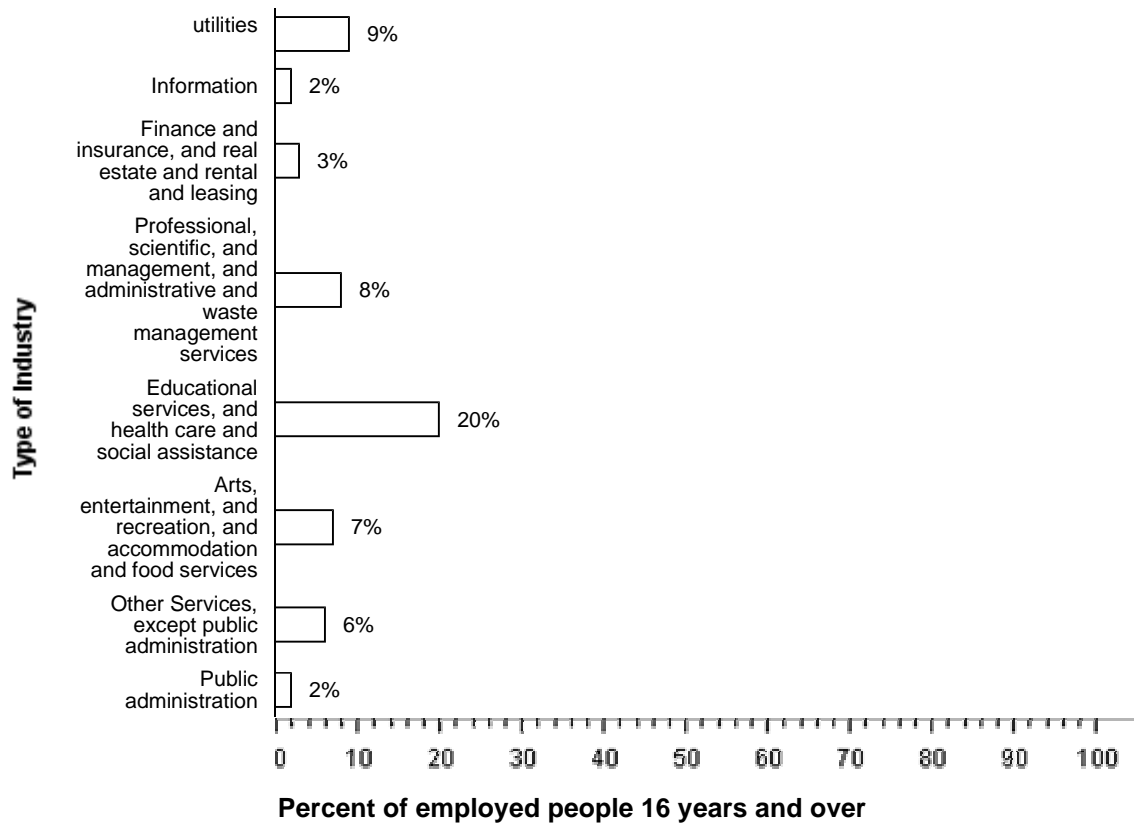

DISABILITY: In Compton city, among people at least five years old in 2007-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2007-2009, for the employed population 16 years and older, the leading industries in Compton city were Educational services, and health care, and social assistance, 20 percent, and Manufacturing, 19 percent.

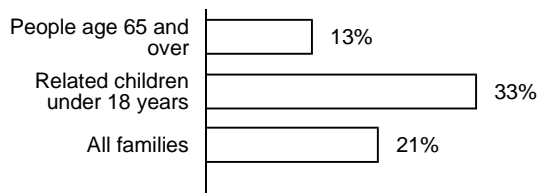
OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Sales and office occupations, 27 percent; Production, transportation, and material moving occupations, 25 percent; Service occupations, 20 percent; Management, professional, and related occupations, 16 percent; and Construction, extraction, maintenance, and repair occupations, 12 percent. Eighty percent of the people employed were Private wage and salary workers; 13 percent was Federal, state, or local government workers; and 7 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy percent of Compton city workers drove to work alone in 2007-2009, 18 percent carpooled, 6 percent took public transportation, and 4 percent used other means. The remaining 2 percent worked at home. Among those who commuted to work, it took them on average 27.5 minutes to get to work.

INCOME: The median income of households in Compton city was \$43,250. Eighty-four percent of the households received earnings and 14 percent received retirement income other than Social Security. Twenty-two percent of the households received Social Security. The average income from Social Security was \$13,603. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2007-2009, 23 percent of people were in poverty. Thirty-three percent of related children under 18 were below the poverty level, compared with 13 percent of people 65 years old and over. Twenty-one percent of all families and 29 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Compton city, California in 2007-2009

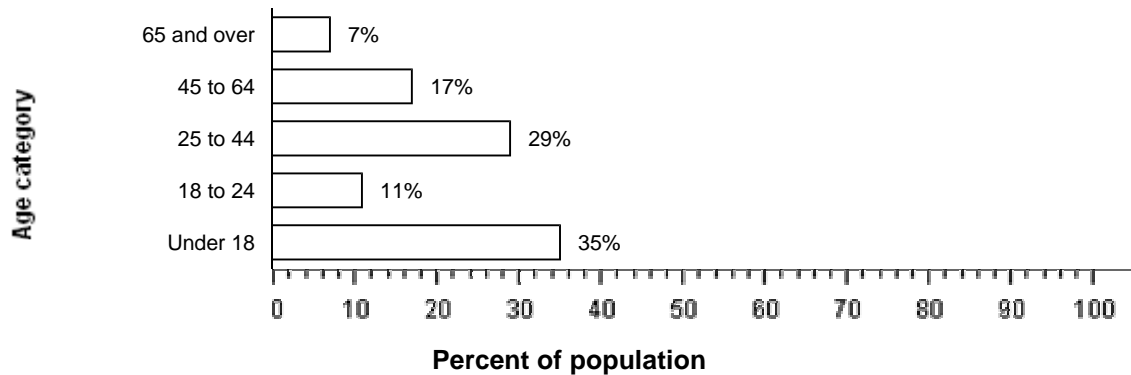

POPULATION OF Compton city: In 2007-2009, Compton city had a total population of 93,000 - 48,000 (51 percent) females and 46,000 (49 percent) males. The median age was 26.6 years. Thirty-five percent of the population was under 18 years and 7 percent was 65 years and older.

The Age Distribution of People in Compton city, California in 2007-2009

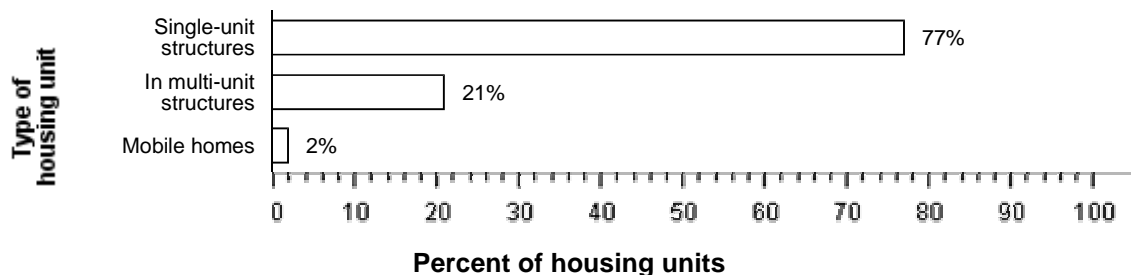

For people reporting one race alone, 34 percent was White; 31 percent was Black or African American; 1 percent was American Indian and Alaska Native; less than 0.5 percent was Asian; 1 percent was Native Hawaiian and Other Pacific Islander, and 31 percent was Some other race. Three percent reported Two or more races. Sixty-five percent of the people in Compton city was Hispanic. One percent of the people in Compton city was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2007-2009, Compton city had a total of 23,000 housing units, 6 percent of which were vacant. Of the total housing units, 77 percent was in single-unit structures, 21 percent was in multi-unit structures, and 2 percent was mobile homes. Six percent of the housing units were built since 1990.

The Types of Housing Units in Compton city, California in 2007-2009

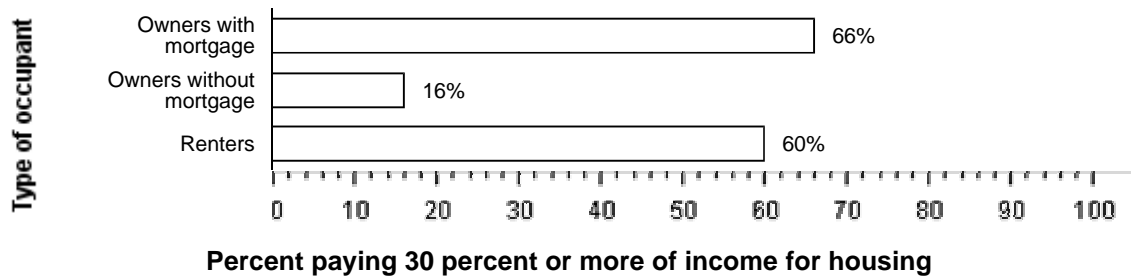

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2007-2009, Compton city had 22,000 occupied housing units - 12,000 (54 percent) owner occupied and 10,000 (46 percent) renter occupied. Three percent of the households did not have telephone service and 9 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Thirty-five percent had two vehicles and another 24 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,921, nonmortgaged owners \$337, and renters \$916. Sixty-six percent of owners with mortgages, 16 percent of owners without mortgages, and 60 percent of renters in Compton city spent 30 percent or more of household income on housing.
