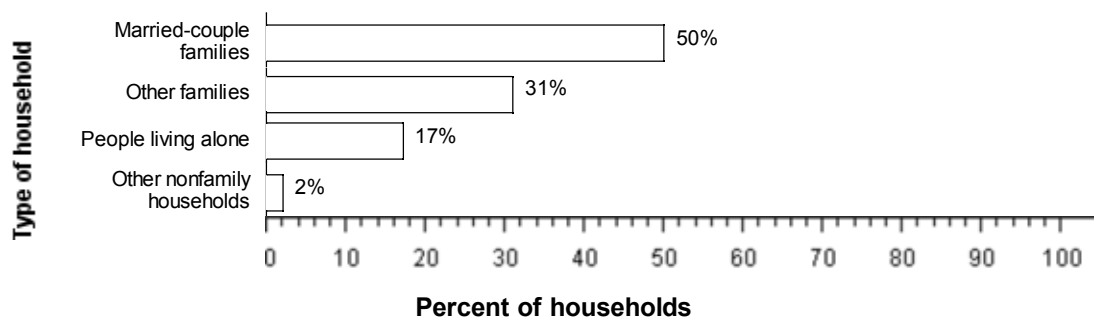
NOTE. HOUSEHOLDS AND FAMILIES: In 2007-2009 there were 14,000 households in Paramount city. The average household size was 3.8 people.

Families made up 81 percent of the households in Paramount city. This figure includes both married-couple families (50 percent) and other families (31 percent). Nonfamily households made up 19 percent of all households in Paramount city. Most of the nonfamily households were people living alone, but some were composed of people living in households in which no one was related to the householder.

The Types of Households in Paramount city, California in 2007-2009



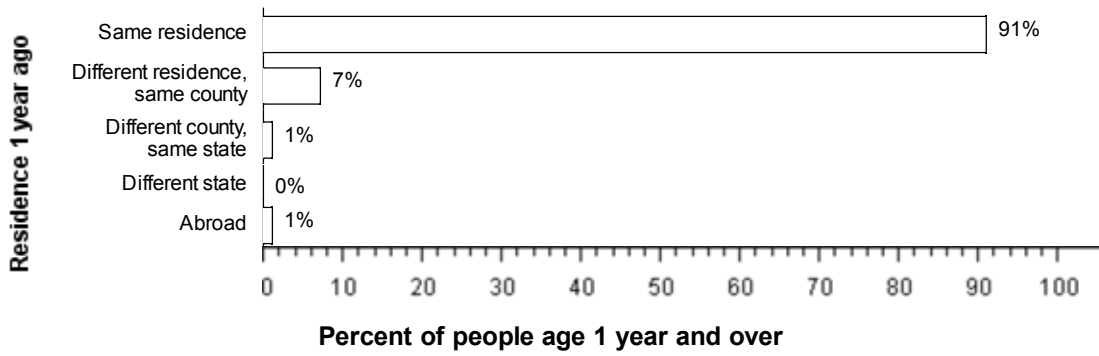

NATIVITY AND LANGUAGE: Thirty-eight percent of the people living in Paramount city in 2007-2009 were foreign born. Sixty-two percent was native, including 55 percent who were born in California.

Among people at least five years old living in Paramount city in 2007-2009, 78 percent spoke a language other than English at home. Of those speaking a language other than English at home, 94 percent spoke Spanish and 6 percent spoke some other language; 49 percent reported that they did not speak English "very well."

GEOGRAPHIC MOBILITY: In 2007-2009, 91 percent of the people at least one year old living in Paramount city were living in the same residence one year earlier; 7 percent had moved during the past year from another residence in the same county, 1 percent from another county in the same state, less than 0.5 percent from another state, and 1 percent from abroad.

Geographic Mobility of Residents of Paramount city, California in 2007-2009

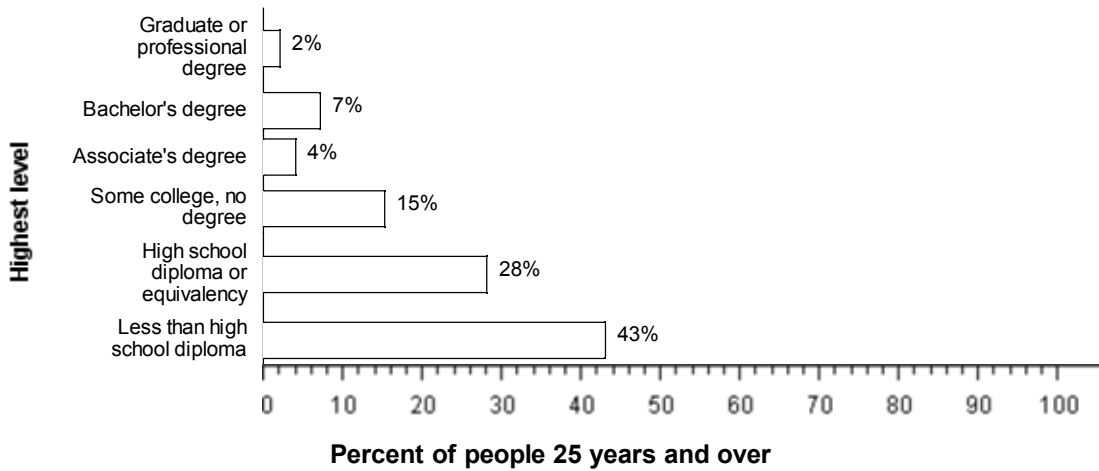

EDUCATION: In 2007-2009, 57 percent of people 25 years and over had at least graduated from high school and 10 percent had a bachelor's degree or higher. Forty-three percent were dropouts; they were not enrolled in school and had not graduated from high school.

The total school enrollment in Paramount city was 18,000 in 2007-2009. Nursery school and kindergarten enrollment was 1,500 and elementary or high school enrollment was 14,000 children. College or graduate school enrollment was 2,900.

The Educational Attainment of People in Paramount city, California in 2007-2009

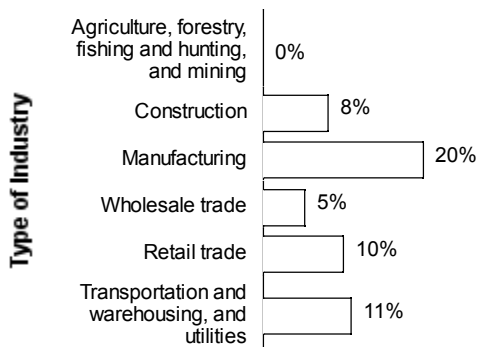


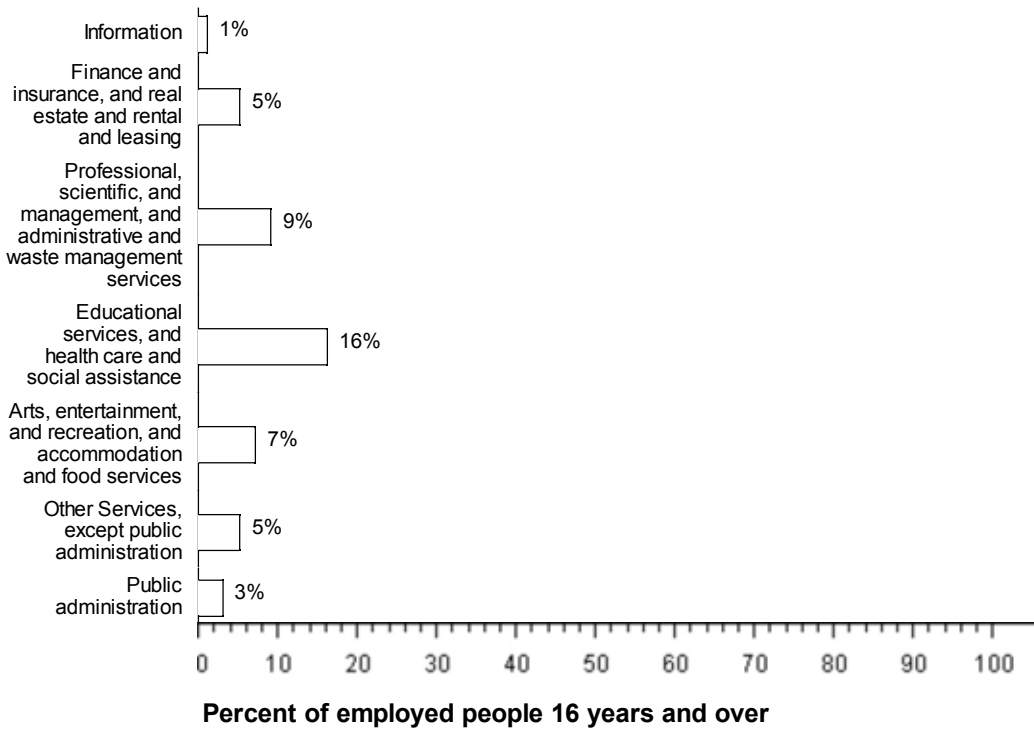

DISABILITY: In Paramount city, among people at least five years old in 2007-2009, percent reported a disability. The likelihood of having a disability varied by age - from percent of people 5 to 15 years old, to percent of people 16 to 64 years old, and to percent of those 65 and older.

INDUSTRIES: In 2007-2009, for the employed population 16 years and older, the leading industries in Paramount city were Manufacturing, 20 percent, and Educational services, and health care, and social assistance, 16 percent.

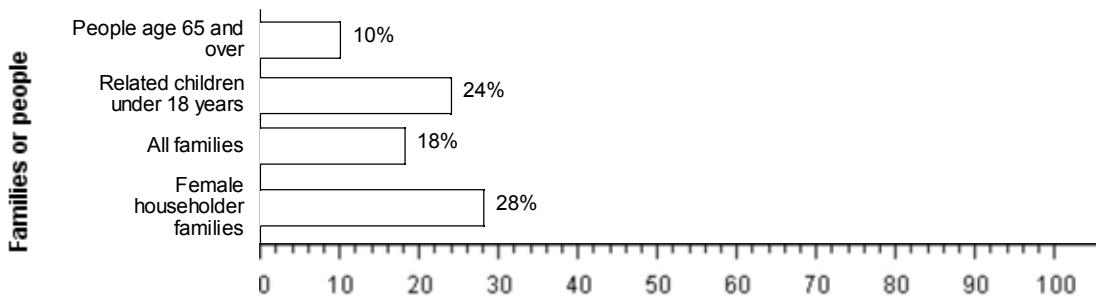
OCCUPATIONS AND TYPE OF EMPLOYER: Among the most common occupations were: Production, transportation, and material moving occupations, 28 percent; Sales and office occupations, 26 percent; Service occupations, 20 percent; Management, professional, and related occupations, 16 percent; and Construction, extraction, maintenance, and repair occupations, 11 percent. Eighty percent of the people employed were Private wage and salary workers; 13 percent was Federal, state, or local government workers; and 6 percent was Self-employed in own not incorporated business workers.

TRAVEL TO WORK: Seventy-three percent of Paramount city workers drove to work alone in 2007-2009, 16 percent carpooled, 5 percent took public transportation, and 4 percent used other means. The remaining 2 percent worked at home. Among those who commuted to work, it took them on average 25.7 minutes to get to work.

INCOME: The median income of households in Paramount city was \$40,420. Eighty-seven percent of the households received earnings and 9 percent received retirement income other than Social Security. Eighteen percent of the households received Social Security. The average income from Social Security was \$12,599. These income sources are not mutually exclusive; that is, some households received income from more than one source.

POVERTY AND PARTICIPATION IN GOVERNMENT PROGRAMS: In 2007-2009, 19 percent of people were in poverty. Twenty-four percent of related children under 18 were below the poverty level, compared with 10 percent of people 65 years old and over. Eighteen percent of all families and 28 percent of families with a female householder and no husband present had incomes below the poverty level.

Poverty Rates in Paramount city, California in 2007-2009

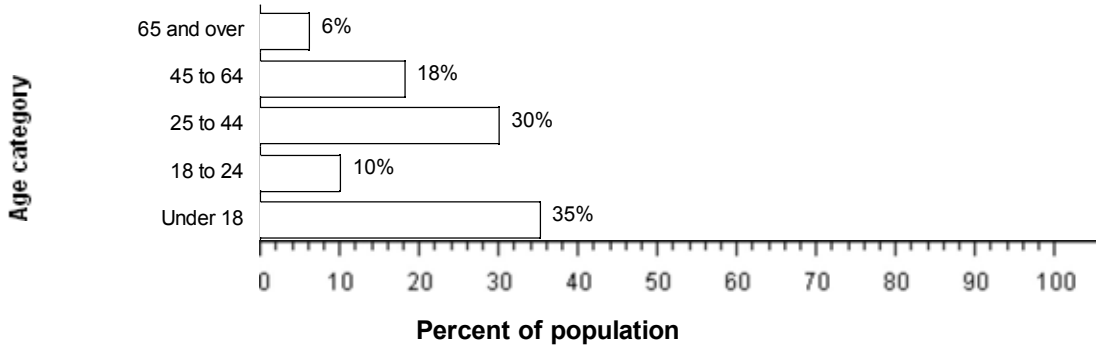


Percent below poverty level

POPULATION OF Paramount city: In 2007-2009, Paramount city had a total population of 55,000 - 28,000 (51 percent) females and 27,000 (49 percent) males. The median age was 28.3 years. Thirty-five percent of the population was under 18 years and 6 percent was 65 years and older.

The Age Distribution of People in Paramount city, California in 2007-2009

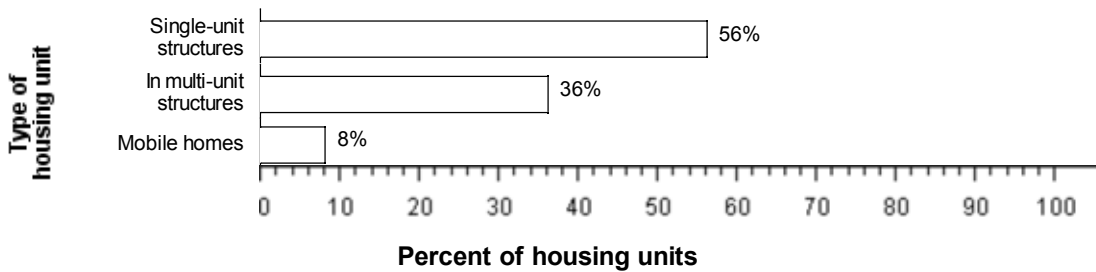

For people reporting one race alone, 31 percent was White; 10 percent was Black or African American; 1 percent was American Indian and Alaska Native; 2 percent was Asian; 1 percent was Native Hawaiian and Other Pacific Islander, and 52 percent was Some other race. Two percent reported Two or more races. Eighty percent of the people in Paramount city was Hispanic. Seven percent of the people in Paramount city was White non-Hispanic. People of Hispanic origin may be of any race.

HOUSING CHARACTERISTICS: In 2007-2009, Paramount city had a total of 16,000 housing units, 7 percent of which were vacant. Of the total housing units, 56 percent was in single-unit structures, 36 percent was in multi-unit structures, and 8 percent was mobile homes. Twelve percent of the housing units were built since 1990.

The Types of Housing Units in Paramount city, California in 2007-2009

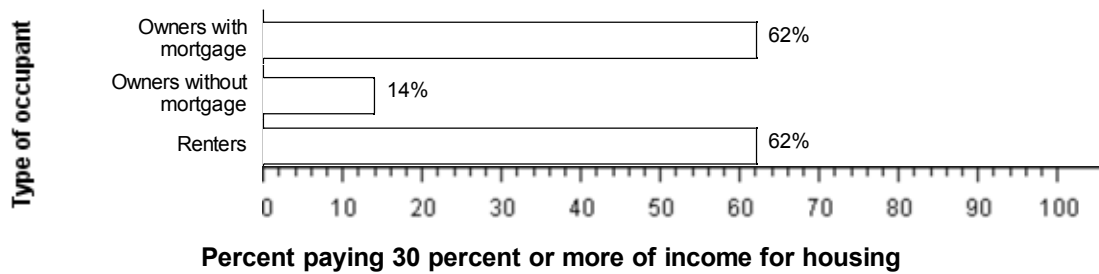

OCCUPIED HOUSING UNIT CHARACTERISTICS: In 2007-2009, Paramount city had 14,000 occupied housing units - 6,700 (46 percent) owner occupied and 7,700 (54 percent) renter occupied. Three percent of the households did not have telephone service and 5 percent of the households did not have access to a car, truck, or van for private use. Multi Vehicle households were not rare. Thirty-six percent had two vehicles and another 20 percent had three or more.

HOUSING COSTS: The median monthly housing costs for mortgaged owners was \$1,790, nonmortgaged owners \$343, and renters \$1,093. Sixty-two percent of owners with mortgages, 14 percent of owners without mortgages, and 62 percent of renters in Paramount city spent 30 percent or more of household income on housing.
