Important Updates

The Public Comment Period Has Been Extended to April 1st!

To allow the public additional time to review the draft Long Beach to East Los Angeles Corridor Mobility Investment Plan (Investment Plan) and provide comments, Metro has extended the public comment period by 30 days at the request of our CBO partners and Supervisor Hahn. It will now end on **April 1, 2024**.
