



LOS ANGELES COUNTY RAIL NETWORK INTEGRATION STUDY

Fact Sheet – Spring 2024

We're planning seamless transfers and expanding access across LA County.

Overview

Metro has a plan to provide a high-quality transit system that delivers a seamless travel experience for everyone in LA County.

Following Metro's Strategic Plan (Vision 2028) and the 2018 California State Rail Plan, Metro initiated a Rail Network Integration Study in summer 2021 to look at opportunities for integrating services between Metro's transit network with the statewide commuter rail system (Metrolink/Amtrak) and future High Speed Rail stations in LA County.

This study focuses on three regional hubs with the greatest opportunities for transfers between the regional and state rail systems outside of Downtown Los Angeles, including **Van Nuys** Metrolink Station, downtown **Burbank** Metrolink Station, Burbank Airport Metrolink Stations and **Norwalk/Santa Fe Springs** Metrolink Station combined with the adjacent Metro C Line Norwalk Station.

What will be studied?

- > State, regional and local needs and priorities for transit network integration, with considerations for accessibility, equity and sustainability
- > Opportunities for first/last mile connectivity, wayfinding and safety improvements, integrated ticketing and customer-friendly amenities
- > Operational enhancements for timed connections to reduce travel time and wait time
- > Travel markets for new express bus shuttles leveraging the state's high-occupancy vehicle lanes (HOV) programs or toll lanes
