La Cienega Station Current Activities

*All work is pending design and City of Beverly Hills approval.

> **Winter 2025/2026 (December 2025 – February 2026*)**

STS implemented a center-lane work zone on Wilshire Bl near Tower Dr

> **Winter/Spring 2026 (February – April*)**

Wilshire/Stanley restoration. Short-term, one and two-lane closures along Wilshire Bl to support curb and gutter restoration between La Cienega Bl and Stanley Dr.

Wilshire/San Vicente Median Restoration

- > Began: December 20, 2025
- > Duration: Scheduled for removal on February 21, 2026
- > Location: Wilshire, San Vicente to Gale Dr
- > Lane Reductions:
 - Wilshire: 2 lanes each direction
 - Eastbound and Westbound Wilshire: 1 lane (off-peak, as needed)
 - Northbound La Cienega: 1 lane (off-peak, as needed)
- > Turn Restrictions:
 - Left turns restricted from Wilshire to Gale and S Tower Dr
 - Left turns maintained at Hamilton and La Cienega

Instrumentation & Punchlist Work

- > **When:** Ongoing
- > **Traffic Controls:**
 - Intermittent lane reductions on Wilshire Bl, La Cienega Bl, and side streets during off-peak hours will be in place to support the **removal** of geotechnical instruments in the Wilshire Bl and La Cienega Bl area.
 - Intermittent lane reductions may be in place on Wilshire Bl, west of La Cienega Bl, to support survey and street maintenance work under Wilshire Bl.
- > Additional details on this work will be available in future construction notices.





Beverly Dr Station Appendage Work

Why: Multiple appendages will be required for each station on the D Line Extension

- > Each appendage structure houses a vital function for the stations:
 - Emergency exits
 - Utility rooms
 - Ventilation rooms
 - Entrance and exit structures

Where: Information about specific traffic control and work hours for specific locations will be available in future community meetings and construction notices


- > Coordination with impacted businesses will be conducted prior to the start of each phase of appendage work



Current Work: Sidewalk and Street Restoration

The contractor implemented closures of the north sidewalk on **Wilshire Bl from N Crescent Dr to Beverly Dr** to perform sidewalk and street restoration work. Pedestrian detours have been implemented, directing pedestrians to use the crosswalks at S Canon Dr and Crescent Dr. Street and sidewalk restoration work will be ongoing and conducted in phases along both sides of Wilshire Bl. Access to the entrance of the AKA commercial property, 9401 building, Sterling, and the Chase bank on Wilshire Bl will be maintained when possible during work activity.

When:

- > Start Date: **January 9, 2026**
- > Work will continue through the month of February

Work hours:

- > Mon-Fri from 8am to 4pm and 8:15pm to 7am

Traffic Control:

- > The north sidewalk from N Crescent Dr to N Canon Dr will be restricted during work activity, and pedestrians will be directed to use detours at the crosswalks at S Canon Dr and Crescent Dr.
- > Wilshire Bl will be reduced to two lanes in each direction from Crescent Dr to Beverly Dr during work activity.
- > Portions of the southbound sidewalk from S Canon Dr to S Reeves Dr and from S Beverly Dr to S Reeves Dr will be restricted during work activity
- > Building and driveway access along Wilshire Bl will be maintained during work activity.

Current Work: Sidewalk and Street Restoration

The contractor will continue through the month of February on **N Canon Dr** to perform street restoration work and reopening of the street. Construction includes the restoration of sidewalk, curb, gutter, street paving and restriping. This work includes the installation of temporary traffic control measures, relocation of the cul-de-sac using cones, and placement of K-rail barriers to separate the work zone from active roadways, while maintaining access to adjacent properties.

When:

- > Start Date: **January 12th, 2026**
- > Work will continue through the month of February with N Canon Dr reopening by mid-March 2026

Work hours:

- > Mon-Fri from 9AM-4PM

Traffic Control:

- > N Canon Dr will remain open with a shifted cul-de-sac during work activity.
- > On-street parking on N Canon Dr will be restricted during work activity.
- > Two parking spaces in front of Spago restaurant (176 N Canon Dr) will be restricted with "No Parking" signage during the duration of work activity.
- > Sidewalks on the east and west sides of N Canon Dr will be closed in phases during work activity.
- > Driveway and building access will be maintained during work activity.
- > Pedestrian access will be maintained during work activity, with temporary detours and signage in place.

Current Work: Sewer Installation on Wilshire Between Carson Rd and Willaman Dr

The contractor has implemented temporary lane closures to support material and equipment delivery and removal, utility maintenance, engineering activities, and other construction-related support work. . This work **started in late January 2026** and is anticipated to be completed **by the end of February**. Work will occur during daytime hours from **9:00 AM to 4:00 PM**. All work will be performed by the contractor and will be implemented per approved worksite traffic control plans and applicable traffic requirements.

When:

> Start Date: **January 27th – February 27th**

Work hours:

> Mon-Fri from 9am to 4pm

Traffic Control:

- > Westbound Wilshire Bl will be reduced to one lane between N Carson Rd and N Willaman Dr.
- > Eastbound Wilshire Bl will be reduced to two lanes between N Carson Rd and N Willaman Dr.
- > Pedestrian access will be maintained during all work activities.
- > Partial sidewalk closures, near curb or parkway, may be implemented to install a manhole.

Current Work: Cross Passage Work Activity

Concrete placement and sewer installation work for tunnel construction continues during the day and night at cross passage 27 (between N Willaman Dr and N Carson Rd) and sewer installation work activity will also be taking place at cross passage 36 (between N Roxbury Dr and N Linden Dr)

Work Hours:

- Concrete placement and sewer installation at CP27 and CP36 through the month of February will occur Monday-Friday, 9am-4pm and 8:15pm-7am
- A more detailed construction notice will be provided to the adjacent stakeholders as needed.

Traffic Controls

- Wilshire Bl will be reduced to two lanes in each direction Monday-Friday during the daytime and evening
- Alley access at Wilshire Bl and Roxbury Dr may be restricted during certain work activities



Current Work: Beverly Dr Station Construction

- > K-rail enclosures have been placed along the northern and southern curb lanes on Wilshire Bl to support ongoing station construction and facilitate appendage and sidewalk construction.
- > Two lanes in each direction will be maintained along Wilshire Bl between Beverly Dr and Crescent Dr during peak hours.
- > Left turns will be restricted from westbound Wilshire Bl to S Canon Dr.

Metro Business Interruption Fund (BIF)

The BIF currently provides financial assistance to small "mom and pop" businesses located along:

- **D Line Extension Sections 1, 2, & 3**
- **East San Fernando Valley Light Rail Transit Project**

Past BIF Eligible Projects include:

- **Crenshaw/LAX Transit Project****
- **Regional Connector Project, Little Tokyo area** & 2nd/Broadway Segment***

***BIF Eligibility ended June 2017.**

****BIF Eligibility ended December 2023.**

BIF Eligibility Requirements:

- **Businesses must be located immediately adjacent to the rail corridor for at least two years.**
- **Have 25 or fewer full-time employees.**
- **Other eligibility requirements as applicable.**

Grant amounts are determined by revenue loss directly related to the period of Metro construction disruption with a maximum of \$60,000 per impact year.


