Salas also indicated documents containing substantial evidence for consideration would be transmitted as well. On 03/03/2025, Sophia Pina, an executive assistant to Chief Andrew Salas, wrote that the tribe had been extremely busy with the Altadena and Palisades fires but offered their commitment to sharing substantial evidence information. On 03/06/2025, the Kizh provided substantial evidence and proposed TCR Section 106 Conditions of Approval.	Accept
